The Humboldt-Toiyabe National Forest is currently advertising for temporary (NTE 1039hrs) Dispatch, Fire Engine, Wildland Fire Module, Helitack, and Hotshot positions. Openings may be available at the GS-03, GS-04, and GS-05 grade levels, with temporary duty/work locations possibly located in: **Nevada (Austin / Carson City / Elko / Ely / Las Vegas / Winnemucca) and in California (Bridgeport / Topaz)** depending on staffing needs and budgets. These are temporary wildland fire positions, with a five to six month tour of duty. Our earliest anticipated start date is late April to mid-May and we expect to operate until late September to mid-October.

2. New applicants must create a new profile within www.usajobs.gov
3. Be sure to indicate the correct duty station(s) of the location(s) of where you wish to be considered.
4. **If interested in any of the positions, it is highly recommended to contact the supervisors listed to receive information about the positions and announcement numbers when they become available.**
5. The Forest is anticipating receiving a list of applicants as early as December 2022.

How to Apply

Through the announcement (when available) you may be instructed to electronically attach additional information (e.g.; resume, DD-214, SF-50, training documentation/certificates, college transcripts, etc.)

The applicant must select the desired “Duty Location City” in order to be considered.

Announcements for these positions are on the USAJOBS website. These web-based applications provide individuals interested in employment opportunities with the Forest Service to apply for jobs. You must log into USAJOBS to create an account and an applicant profile. www.usajobs.gov.

WORK CAPACITY TEST (WCT) for Wildland Firefighters: These positions participate in wildland firefighting activities. Based on the type of work performed, PASSING the Work Capacity Test at the arduous level is a "condition of employment." The arduous fitness (Pack) test consists of a three (3) mile hike, within forty-five (45) minutes, while carrying a forty-five (45) pound pack. You are strongly encouraged to consult with your physician and begin training immediately if you are applying for these positions. This announcement constitutes the required 30 days advanced notice for testing requirements.

About the Forest

At over 6.3 million acres, the Humboldt-Toiyabe National Forest is the largest National Forest in the contiguous United States. The Forest spans the state of Nevada, and includes one million acres of land in eastern California, along the eastern Sierra Front. The Forest consists of four distinct geographic areas: the Sierra Nevada, Central Nevada, Northeastern Nevada, and the Spring Mountains (Las Vegas).
